About us:

People, initiatives and institutions in Berlin are subject to hate crimes almost every day. With the emergency aid fund, the Amadeu Antonio Stiftung offers people affected by hate crime solidarity and support through immediate financial aid. The funds are sponsored by the Unterstützungsfonds der Landeskommision Berlin gegen Gewalt (Support Funds from the Berlin State Commission against Violence).

Hate crimes are ...

Threats, abuse, insults, physical injury and material damage:

- ... that are motivated by enmity such as ableism, anti-feminism, hostility towards Romani and Sinti people, LGBTQI* hostility, racism, hostility towards the homeless etc.
- ... that are directed against the commitment for the democratic and human rights principles of people.

Our support:

- Emergency financial aid of up to 1,000 euros per individual case
- Consultation for making applications (by telephone, digitally or in person, anonymous upon request)
- Individuals can make applications
- Individuals can also make applications in their work context for parties, associations, initiatives or institutions.

Examples of costs we assume:

- Rectification of material damage
- Medical treatments
- Psychological support
- Lawyer's costs
- Empowerment and self-defence courses
- Supervision

Do you live in Berlin and have you been attacked or threatened in a racist, anti-Semitic, LGBTQI*-hostile or other misanthropic way?

Have you become a target for hate due to your commitment for democratic and human rights principles?

Has an attack or threat resulted in costs?

We are happy to support you. Make an application with us for financial support, because nobody should be left to cope with these costs alone!

- Financial support in cases of hate crimes and threats
- Free consultation for making an application
- **Partisan:** we stand by those affected with solidarity!
- **Confidential:** information will not be passed on to third parties
- **Independant** of assesment by the police or courts
